

# Community Center Survey Results

#### Methods

Telephone interviews performed by speciallytrained opinion research interviewers

Conducted with 300 randomly-selected registered voters residing in Upper Arlington, Ohio, using a combination of valid residential, VOIP and cellular telephone listings

+/- 5.65% overall estimated margin of error, with a confidence interval of 11.3% within which the results can vary

November 16 – November 20, 2020

Data was stratified so that the differences in vital characteristics, such as age, gender and geography are represented in proportion to their percentages of the city's electorate

Due to rounding, not all results add up to 100%, and the data is presented in a different order than the questions were asked

Unless otherwise noted, only statistically-significant differences that were outside the confidence interval for the overall estimated margin of sampling error have been reported in this presentation of key findings




Would you support or oppose including medical facilities and offices in the community center for private healthcare providers that serve local residents, such as doctors' offices, physical therapy practices and other services?


Would you say that property taxes in Upper Arlington are too high, mostly pretty fair or too low?

#### Awareness

Total "informed" awareness was modestly high, but most have not heard a lot about the proposed community center and will still be responsive to new information; there appears to be some association with support and levels of information suggesting that the more residents have heard about it, the more they liked it



Based on what you know at this time, do you support or oppose having the city construct a community center for athletics & fitness, arts, recreation and civic uses in Upper Arlington?















### Property Tax

Although comparatively lower, support for a tax increase was well above the majority threshold, but the outcome of an election might be closer due to some key sub-group differences
