The meeting of the Citizen Financial Review Task Force was called to order at 8:16 a.m. in the Lower Level Meeting Room, located at 3600 Tremont Road by Chairperson Ann Gabriel.

#### 1. Approval of Minutes of May 2, 2019 Meeting

Ms. Crane moved, seconded by Mr. Gawel, to approve the minutes of the May 2, 2019 Citizen Financial Review Task Force Meeting.

Motion carried.

#### 2. Overview of Economic Development Department

The Economic Development Director came forward and provided a PowerPoint (attached hereto and incorporated herein by reference as Exhibit A). He conveyed he works under the City Manager's Office and his job is to help build a strong economic base for Upper Arlington.

Chair Gabriel questioned what the Economic Development Director is most proud of. The Economic Development Director conveyed new projects coming in will not receive an incentive unless they provide some sort of office space. The City is increasing the office space and there has been a big push for more office over the last five years. He said most of the office buildings in UA were built with no elevators and are very outdated. They are working to make them ADA compliant and more modern. A lot of these buildings were 80% occupied on the first floor, and 10% occupied on the second. Once buildings have these upgrades, they are seeing interest from tenants.

Chair Gabriel questioned looking back if there was anything he would have done differently. The Economic Development Director said when he looks at Lane Avenue and Kingsdale, there have been discussions on how they can bring more uniformity to those areas. He advised people want unique areas and he wants to continue the growth of those areas.

Chair Gabriel questioned what are the Economic Development Director's goals going forward. The Economic Development Director advised there are a lot of projects on the table and he wants to see those through to completion. He continues to meet with businesses and keep good relationships with them.

Chair Gabriel questioned what keeps him up at night. The Economic Development Director advised UA is moving in a great direction, and he was drawn to UA because of the community. His fear is that the cost of development will continue to rise and when it rises it makes it harder to have redevelopment. His biggest fear would be that the cost of redevelopment will make it difficult to compete.

Chair Gabriel asked what additional support from the City is necessary to accomplish his goals, the Economic Development Director advised they work with about \$500,000 a year for incentives. The more money the more projects and incentives they could offer. He conveyed when looking at UA's neighboring communities, they are offering more money when working with developers. He added another thing is the ability to have someone doing BRE visits, and getting to know the community.

In response to Mr. Keen, the Economic Development Director confirmed the \$500,000 is for large businesses, small businesses, and job creation. It does not cover TIFs and Community Reinvestment. Mr. Keen asked how many active CRA's the City has, the Economic Development Director advised currently there are two.

Mr. Kirby questioned if there are specific areas of the community Staff has targeted as potential redevelopment; and other than the Chamber, if there is anything else in terms of outreach for existing businesses and their development. The Economic Development Director advised there are target areas, they have a list, and within that list they know which ones are more likely to happen than others. He related as far as outreach, there are organizations like Columbus 2020, meeting them or calling them, and doing BRE visits with top businesses. He added the Chamber is the most formalized way of getting them all together.

Mr. Rule questioned if there have been discussions about expanding CRA districts. The Economic Development Director advised they have not discussed expanding the CRAs, they would like to use TIFs more. The Finance Director advised they try to stay away from abatements, and have not been in a situation where a CRA has come up recently.

Mr. Gawel stated he recently learned about the importance of the CompuServe area and questioned what that area is referred to. The Economic Development Director responded he refers to that area as Arlington Boulevard. Mr. Gawel

advised he thinks people have a hard time grasping the importance of it. The Economic Development Director said to redevelop that site would have a big impact on UA.

In response to Mr. Rule the Economic Development Director advised Grandview Yard was a big change for Grandview, and Bexley has Capital University. He advised UA needs to continue to build the density on Lane Avenue and Kingsdale.

Mr. Rule related there are a lot of discussions about the Lane Avenue corridor but questioned why the Henderson Road corridor is not in the mix and asked what is proactively being done there. The Economic Development Director advised Upper Arlington only controls half the development pattern on that street. He added there is a draw for businesses to Lane Avenue because of the walkability and proximity to Whole Foods, restaurants, and shops.

#### 3. Overview of Community Development Department

The Acting Community Development Director came forward and provided a PowerPoint (attached hereto and incorporated herein by reference as Exhibit B). He related he has been with the City approximately 16 years, and before coming here, he was with the City of Dublin.

Chair Gabriel questioned what keeps him up at night. The Acting Development Director advised making sure the developments are thought through completely and it is very important to him to have a positive impact on these projects.

Ms. Jeter questioned the financial figures for the immediate department needs, and if the costs will be covered by revenue. The Acting Development Director advised he believes some of the contracts will need bumped up but all of those overages will remain in the revenue stream.

Ms. Jeter questioned if the permit software the Development Department uses is adequate. The Acting Development Director responded currently the Department is using Viewpoint and it is a fantastic system. He said it allows them to accept permits and payments electronically.

Mr. Gawel questioned if there have been discussions about linking the High School to the new Lane II. The Acting Development Director advised the City's Master Plan ties everything together and recognizes this importance.

#### 4. Overview of Police Division

The Police Chief came forward and provided a PowerPoint (attached hereto and incorporated herein by reference as Exhibit C). He advised he was with the City of Dublin for 22 years and it prepared him well for the challenges he is seeing here.

In response to Chair Gabriel regarding the Police Department's capital equipment budget, the Police Chief advised there is a schedule for replacing vehicles. He advised Ford has come out with a hybrid that is being promoted for police, they lose nothing on performance, and there may be some cost savings over the life of

the vehicle. He advised they will look at the data to see if that is the best way to go in the future.

The Finance Director advised they try to stay on a regular cycle of replacing one to three police cars a year. The Police Chief advised they did add one vehicle this year and they were able to fund that with forfeiture funds.

Mr. Gawel asked if the opiate problem has impacted police work. The Police Chief advised it has, not in policy, but in shared services. For instance, if there is an overdose, investigators work with the Franklin County HOPE task force to track it back to the provider of the drugs. The Police Chief said he wants to make sure they are staying on the cutting edge and are a leader in Central Ohio.

#### 5. Overview of Fire Division

The Fire Chief came forward and provided a PowerPoint (attached hereto and incorporated herein by reference as Exhibit D). He advised he has been with the City for 31 years.

Mr. Rule questioned if there is a fire in a building that is over five or six stories does that requires different capital equipment, the Fire Chief responded it requires different staffing.

Mr. Keen questioned the most common cause of home fires in UA. The Fire Chief responded electrical, extension cords, and some have been from home repairs.

Mr. Rule praised the Fire Department for diving into the CARES Program, he said it is nice the Fire Department is doing this proactively.

#### 6. Discussion of Steps to Final Report

Chair Gabriel advised she believes they are coming into the deliberation phase. They will talk to Finance next week and proposed at the meeting on Wednesday to concentrate on the recommendations from the 2014 Task Force.

#### 7. Public Comment

In response to Chair Gabriel's invitation to speak:

Rachel Wyant advised she is the new intern with the City Manager's Office. She said it was helpful to sit in on this.


